

RESOLUTION No. 194

A RESOLUTION OF THE CITY OF WEIPPE, CLEARWATER COUNTY, IDAHO
ADOPTING CITY OF WEIPPE'S FEE SCHEDULE

WHEREAS, the City of Weippe has reviewed all fees charged for services; and

WHEREAS, the City of Weippe has determined that periodic revisions may be necessary.

WHEREAS, the City has fees for services already established; and

WHEREAS, the City of Weippe has determined that the fee schedule be amended to reflect the reasonable cost of providing the services; and

WHEREAS, after public hearing on October 13, 2025, has been held prior to the adoption of this resolution, in accordance with Idaho Code Section 63-131 IA, regarding new increased city fees, it is deemed by the city council to be in the best interests of the City of Weippe and the citizens thereof that the fee schedule be amended to include the new and increased fees which were addressed in the public hearing.

NOW THEREFOR, BE IT RESOLVED, by the Mayor and City Council of the City of Weippe, Idaho that the following fee schedule, which reflects the new and amended fees; and the existing fees that have not been amended, be adopted effective the 1st day of October, 2025:

- ❖ Anything over 6,000 gallons is an additional .50cents per 1,000 gallons.
- ❖ A deposit of S 175.00 is required for all new accounts for water-sewer-garbage service. This will be refunded at the end of 1 (one) year residency after all bills for water-sewer garbage are paid in full. This amount is based on a monthly average for city utilities and is subject to change. Property owners who sign an agreement with the City, there is no deposit required from renters.
- ❖ Accounts not paid in full by the last billing day of the month shall be assessed a \$10.00 delinquent fee.
- ❖ \$25.00 charge to turn water on and the city is forced to do so due to a delinquent account.
